

## UWHC Supplemental Retirement Plans

### Tax Sheltered Annuities (TSA) – 403(b)

**Eligibility:** All regular full-time, part-time and temporary employees of UW Hospital and Clinics.

**To Enroll in a TSA:** Contact your vendor(s) of choice and request a 403(b) start-up kit/application. Be sure to identify yourself as a UW Hospital and Clinics employee and provide the vendor account number listed below. (Please note that employees may not enroll on the vendor’s website. A paper application is required.) Submit the vendor application(s) and beneficiary designation directly to the vendor. When you receive confirmation that your account has been established, submit a Salary Reduction Agreement (SRA) to UW Health Human Resources.
