1. Call to Order

Chair David Walsh called the meeting to order at 7:55 a.m. A quorum was present. Mr. Walsh introduced two new members to the Board; Chancellor Rebecca Blank, and Regina Millner, a new representative from the Board of Regents.

Approval of Minutes of the August 7, 2013 Authority Board Meeting

Dean Golden moved approval of the minutes of the August 7, 2013 meeting (Attachment A). Mr. Weiden seconded the motion, and it passed unanimously.

3. Review and Approval of Medical Staff Memberships and Clinical Privileges

Dr. Rudin presented the Medical Board recommendations concerning medical staff memberships and clinical privileges (Attachment B). Dean Golden moved that the recommendations be approved. Dean May seconded the motion and it passed unanimously.

4. Collective Bargaining Presentation

Approximately 25 representatives from AFSCME Council 24 and SEIU Healthcare Wisconsin addressed the Board. Marty Beil, from AFSCME, stated that SEIU and AFSCME represent 5,000 UWHCA workers. Presenting a "Quality Care Report," Mr. Beil stated that "collective bargaining and quality go hand in hand." Dian Palmer of SEIU echoed Mr. Beil's comments. A number of workers addressed the Board, identifying areas from the Quality Care Report where they thought collective bargaining enhanced quality. They asked that the Board stand with the union employees. They requested a meeting to discuss options for maintaining a relationship with the unions.

5. Other Matters

No other matters were discussed.

In closed session, the Board, on a motion by Mr. Weiden, and seconded by Ms. Mueller, approved a resolution for UWHCA to make a contribution to United Way of Dane County to support the United Way initiative to subsidize health insurance premiums. The United Way initiative covers persons with incomes between 100-133% of the Federal Poverty Level electing coverage through the exchanges.

On motion by Mr. Weiden, seconded by Chancellor Blank, the Board unanimously approved an amendment to the Annual Academic Advancement Agreement for fiscal year 2014.

The Board took no other action in the closed session.

At 11:35 a.m., Dean May moved to adjourn the meeting. Mr. Weiden seconded the motion, and there was a unanimous vote to adjourn.
